The scope of the survey work will be for a period of two years (Three seasons for a year viz. Summer/Rainy/Winter). Field visit to the area by concerned scientist and team to make an overall Survey of area for its approach road routes and arrangements for accommodation & explorations. Regular visit by concerned experts for collection of data/sample/specimens includes mobilization of human resource and materials. Botanical classification of collected sample with details and preparation and submission of herbarium for preservation by Nalco. Compilation of collected data and preparation of reports. Submission of final report along with photographs & Albums.
