

At the outset of the hearing, the Solicitor General told the Bench that the Central government is seeking a reference of the matter to a larger Bench. The Bench also comprising Justices MR Shah, Krishna Murari, Hima Kohli and PS Narasimha expressed surprise at the plea made at the fag end of the hearing. Mr Mehta, however, pressed that reference is needed and added that they do not want to be remembered in history for "handling over capital to complete anarchy".

The CJJ told Mr Mehta that

Mr Singhvi, opposed the submissions of the Solicitor General. The Bench, however, allowed the Centre to give its note on the point of reference. It later reserved its judgment in the case.

The application for referring the matter to a larger bench was sought in a matter of 2018 when the Constitution bench went against a 1997 Supreme Court ruling of a nine-judge bench which held Delhi is a Union Territory and not a State despite having a legislative assembly.
